INVITATION TO BID

The Jefferson County Board of Health (the "Board") and the Jefferson County Department of Health (the "Department") (collectively, "JCDH") will be accepting sealed bids for **Reference Laboratory Testing Services including Pap Smears** which will be received by:

until 10:30 am CST., Wednesday, August 21, 2024, (the "Bid Period") at which time and place they will be publicly opened and read. The Project will involve an expenditure in excess of thirty thousand dollars (\$30,000) and is subject to competitive procurement provisions of the Alabama Bid Law, Ala. Code 41-16-50 et seq.

A. SCOPE OF WORK AND MATERIALS

Prospective bidders may download the complete solicitation including the specifications and bid forms via the internet at <https://jcdh.org/SitePages/About/Bids.aspx>, or by visiting the Purchasing Office at the address shown above, or by calling (205) 930-1961, fax (205) 930-1060 and requesting a copy be mailed to you. Any addenda will be available on the JCDH website.

Bidder is responsible for checking for addenda until bid opening date. Addenda will be mailed only to those vendors who were provided a copy in person or by mail. **Bidders are strongly encouraged to read the entire solicitation.**

B. BIDS

All bids must be submitted on Bid Form in a sealed envelope indicating **"SEALED BID – ITB# 24-08-18, "Reference Laboratory Testing Services including Pap Smears"** with opening date and bid number printed on outside of envelope.

All bidders must complete and provide the following:

- The notarized State of Alabama disclosure form included in the bid package;
- The Addendum to ITB Agreement Contract;
- A copy of their E-verify certificate with the assigned number from the U.S. Department of Homeland Security;
- A W-9 Form;
- City of Birmingham/Jefferson County Business License;
- The Beason-Hammon Alabama Taxpayer and Citizen Protection Act Supplemental Form; and
- All other documents listed in the enclosure.

C. BONDING

It is **required** for any contract/purchase exceeding \$10,000.00 that the bidder submits with their bid a certified check, a cashier's check or a bid bond payable to the Jefferson County Department of Health in the amount of \$500.00. For any bid award to be considered that exceeds \$10,000, it must be accompanied by an acceptable bid bond or check. Bid bonds will be returned to all unsuccessful bidders after the formal award is made and to the successful bidder after acceptance of the award. Should the successful bidder fail to accept the award, the bid bond or check shall be forfeited.

D. OTHER BID REGULATIONS AND REQUIREMENTS

- No bid may be withdrawn for a period of sixty (60) days after the date of the bid opening.
- JCDH reserves the right to reject bids if such action is determined to be in the best interest of JCDH.
- JCDH reserves the right to reject any or all bids or parts of bids and to make the award either “all or none” or per line item on the merit and/or feature of method and quality, delivery, and service availability as the best interest of JCDH appears.
- JCDH is exempt from all tax. This statement in no way is to be construed as relieving a seller or contractor from paying any tax assessed to him as a seller or contractor.
- JCDH reserves the right to require documentation that each bidder is an established business and is abiding by the ordinances, regulations, and laws of their community and the State of Alabama.
- If you are required by any regulatory agency to maintain professional license or certification to provide any product and/or service solicited under this ITB, JCDH reserves the right to require documentation of current license and/or certification before considering and awarding the bid.

E. COMMUNICATION DURING BID EVALUATION

There shall be no communication during the evaluation period between any vendor and JCDH agency requisitioning the good or service to be procured. Any communications, written, oral, or electronic between the vendor and the requisition agency must come through the Division of Purchasing Buyer administering the ITB.

F. QUESTION/INQUIRY

Telephone inquiries with questions regarding clarification of all specifications of the ITB will not be accepted. SPECIFICATIONS

A. STATEMENT OF PURPOSE

The Jefferson County Department of Health is currently soliciting sealed bids for **Reference Laboratory Testing Services including Pap Smears**. Proposers eligible to submit an ITB must not be on the U.S. General Services Administration lists of Parties Excluded from Federal Procurement or Non-Procurement Programs. The successful bidders will be notified of bid award via the Jefferson County Department of Health's Notice of Award letter and the approved Standard Addendum to ITB Agreement Contract.

No Bid will be considered unless the Proposer, whether resident or non-resident of Alabama, is qualified to submit a bid. The Jefferson County Department of Health reserves the right to reject any and all Bids and to waive any formalities in the solicitation process, and to be the final authority in any conflict.

B. ABOUT JCDH

Based in Birmingham, AL, JCDH is an independent, semi-autonomous local health department in the most populous county in Alabama serving approximately 665,000 residents. JCDH's mission is to prevent disease and assure access to quality healthcare, *promote* a healthy lifestyle and a healthy environment, and *protect* against public health threats. We envision a healthier Jefferson County for all. The strategic plan of the Jefferson County Department of Health is developed with intentional focus on health equity. To us, health equity means that everyone has the opportunities needed to attain their highest level of health. We seek to reimagine systems of care and help build local healthcare ecosystems where communities are safe, engaged, served and healthy.

C. BIDDER CONTRACTS

Successful firm will be the only contract. Bids will not be accepted from vendors that sub-contract their work.

D. AWARD

The Award will be made in whole to the lowest responsible bidder provided the bidder meets all requirements and specifications required by JCDH and the bidder meets all requirements under the Alabama Competitive Bid Law.

E. TERMS

The bid will be valid from October 1, 2024 until September 30, 2027. The successful bidder will be notified of ITB award via JCDH's Notice of Award letter and the approved Standard Addendum to Bid Agreement Contract.

A. TERMINATION

The contractual agreement or addendum associated with any bid response may be terminated by JCDH with a thirty (30) day written notice of cancelation to the other party regardless of reason.

Any violation of the agreement or addendum associated with any bid response shall constitute a breach and default of this agreement. Such termination shall not relieve the contractor of any liability to JCDH for damages sustained by virtue of a breach by the contractor.

B. PRICE

Pricing will remain firm for the entire duration of the bid period. Price must include **all** related fees. Invoice(s) must be itemized and billed after delivery.

C. FREIGHT

Prices are to include transportation, fuel, handling, service, freight charges and deliveries/pick-up as specified. JCDH will pay no additional fees unless previously agreed to in writing.

D. TAX

JCDH is exempt from all tax. Bidder shall be responsible for any tax that may be levied or assessed by reason of this transaction.

E. PRE-PAY

No pre-payments will be made.

F. ADDITIONS TO CONTRACT

JCDH has attempted to list all aspects of the Project that will be required during the term of the Agreement. However, JCDH reserves the right to delete or add additional locations, quantities and/or related items as needed from the successful bidder.

G. INTERPRETATIONS

No modification, deviation, substitution, or other such changes will be made without the prior written approval of JCDH. JCDH reserves the right to reject any or all bids submitted and to make the award in the best interest of the Health Department.

H. INSURANCE

Bidder shall furnish to the Board upon execution of this Agreement, a certificate of insurance as evidence of adequate professional and public liability insurance insuring vendor, the Board and Board's agents, servants, and employees as additional insured.

I. OTHER BID TERMS AND CONDITIONS

- Bids will be rejected if there is reason to believe that collusion exists among the bidders. No participants in such collusion will be considered in future bids for the same work.
- Bidder must have all necessary business licenses as required by the State of Alabama, Jefferson County and the City of Birmingham.
- All items must conform strictly to the specifications and shall be subjected to evaluation upon acceptance. In the event that any item is deemed unacceptable or not in conformity with the specifications, such items will be rejected, and items of proper quality as set forth in the specifications shall be furnished in place thereof at the expense of the successful bidder.
- Failure to comply in accordance with the awarded bid as submitted, including promised delivery, will constitute sufficient grounds for cancelation of the order and the Contract at the option of JCDH.
- Use of specific names and numbers is not intended to restrict the bid of any bidder, seller and/or manufacturer but is solely for the purpose of indicating the type, size and quality, material, service, or equipment considered best adapted to the JCDH's intended use.
- Bidder will furnish a minimum of three (3) references. References will be accepted only from companies that provide similar type of scope of work as requested herein.
- No bidder shall be allowed to offer more than one bid for the said project. If said bidder should submit more than one bid for the said project described therein those bids shall be rejected.
- No bidder shall be allowed to offer more than one price on each line item. If said bidder should submit more than one price per line item, then ALL prices for that line item shall be rejected.

J. INCURRING COSTS

The Jefferson County Department of Health will not be liable for any costs incurred in preparing bid responses.

K. NUMBER OF BIDS

One (1) original AND one (1) copy may be submitted with bid package. Bids shall be prepared in accordance with the bid format using the bid form. Bids not complying with this format may be considered non-responsive and may be removed from consideration on this basis.

L. APPLICABLE LAW

A contract entered into as a result of this bid shall be governed and interpreted under the laws of the State of Alabama. The contract shall be on a standard JCDH form as modified for this particular transaction. As JCDH is a public agency, its standard contract contains provisions required by Alabama law and regulations. Those provisions include, but are not limited to, the following topics.

Ala. Code 41-4-142 provides that every bid submitted and contract executed shall contain a certification that the vendor, contractor, and all of its affiliates that make sales for delivery into Alabama, or leases for use in Alabama, are registered, collecting, and remitting Alabama state and local sales, use, and/or lease tax on all taxable sales and leases into Alabama. **BY SUBMITTING THIS BID, THE FIRM IS HEREBY CERTIFYING THAT THEY ARE IN FULL COMPLIANCE WITH ALABAMA LAW, THEY ARE NOT BARRED FROM SUBMITTING BIDS OR ENTERING INTO A CONTRACT PURSUANT TO ALA. CODE 41-4-142, AND ACKNOWLEDGE THAT THE AWARDING AUTHORITY MAY DECLARE THE CONTRACT VOID IF THE CERTIFICATION IS FALSE.**

Ala. Code 31-13-9(k) provides the following language must be included in every public contract bid in Alabama: "By signing the Agreement and this Addendum, the Board and the Contractor affirm, for the duration of this Agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, any Contracting Party found to be in violation of this provision shall be deemed in breach of this Agreement and shall be responsible for all damages resulting therefrom."

In addition, any Contractor that employs one or more employees in the State of Alabama must provide evidence of their participation in the federal E-Verify program.

Acceptance of standard JCDH contract terms and execution of the contract are essential element of the award. Failure to enter into the contract will result in forfeiture of the award. A copy of the form "Addendum to ITB Agreement Contract" may be obtained upon request from the Purchasing Agent.

M. GUARANTEE

Bidder certifies by submitting a bid that bidder is fully aware of the conditions of service and purpose for which item(s) included in this bid are to be purchased, and that their bid will meet these requirements of service and purpose to the satisfaction of the Jefferson County Department of Health and its Agent.

List of lab test and pick-up locations may be amended as needed of the Jefferson County Health Department change over term of the contract.

Failure to deliver as specified and in accordance with the bid submitted, including promised delivery, will constitute sufficient grounds for cancelation of the order and contract at the option of the Jefferson County Department of Health.

No bidder shall be allowed to offer more than one price on each product. If said bidder should submit more than one product per line item then ALL prices for that line item shall be rejected.

Quantities shown are estimates and are not a guarantee to buy in the amount shown. Merchandise shall be ordered as needed. No bidder shall attempt to hold the quantities shown as a firm quantity under this contract.

Use of specific names and numbers is not intended to restrict the bidding of any seller and/or manufacturer, but is solely for the purpose of indicating the type, size and quality of materials, products, service, or equipment considered best adapted to the JCDH's intended use.

If requested, successful bidder will furnish a minimum of three (3) references. References will be accepted only from companies that provide similar services with same type and scope as requested herein.

No bidder shall be allowed to offer more than one price on each line item. If said bidder should submit more than one price per line item, then ALL prices for that line item shall be rejected.

REQUIREMENTS:

Section - I: Acceptable Candidates must meet all of the following criteria:

- a) Bidder must provide reference laboratory testing services (tests other than those performed by Jefferson County Department of Health or provided by or contracted through the Alabama Department of Public Health or specialized tests performed by UAB) for all health centers and any additional clinics, which may be added during the period of the contract.
- b) Bidder must provide daily courier service to each laboratory site to transport the specimens from each health center or additional clinic sites to the reference laboratory facility. Provide courier service for STAT laboratory tests as needed. Services at the Board's health centers and other off-site clinics, which may be added, are provided Monday through Friday from 7:45 a.m. until 4:30 p.m.
- c) Bidder must provide in-house phlebotomy services for all the Jefferson County Department of Health centers during the standard time of operations, Monday through Friday from 7:45 a.m. until 4:30 p.m. At a minimum, Bidder will provide four phlebotomists to be assigned as follows: Two (2) Phlebotomist assigned in Disease Control Specialty Clinics and Central Health Center; One (1) Phlebotomist assigned to Western Health Center and one (1) Phlebotomist assigned to Eastern Health Center.
- d) Bidder must supply all Tests ordered and results received via bi-directional interface with Jefferson County Department of Health Electronic Medical Record (EHS). Bidder must have a current fully configured and bi-directional functional interface with the Department's Electronic Medical Record (EHS).

The successful vendor must be currently integrated with the AthenaHealth EMR with a HL-7 bi-directional interface which must be fully configured and functional. Contract will be signed when interface is completed and accepted as working to satisfaction of Department. Failure to comply within time limit may result in disqualification of bid.

The Jefferson County Department of Health will not be responsible for any expenses or time incurred by vendor to interface or configure components with our current system. The results that are reported electronically must use the HL 7 format. Results must be transmitted electronically in the HL7 format. Orders and results must be transmitted using TCP/IP socket based connection. The lab vendor must provide a full compendium consisting of lab and result codes in the desired format as provided by the Electronic Medical Record vendor (SuccessEHS). The compendium codes will be mapped accordingly to the corresponding SuccessEHS CPT and result codes. The vendor must be able to provide updates to the Electronic Medical Record vendor (SuccessEHS) when changes occur. The vendor must return the same order code in the ORU message as received in the ORM message. Reflex tests must be handled using OBR-11 (Specimen Action Code = 'G') and OBR-29 (Parent Order Code). Order and result statuses must be reported in OBR and OBX segments accordingly in the ORU message for proper tracking (P = Preliminary, F = Final, C = Corrected Final, X = Cancelled). The value received in MSH-4 of the ORU message MUST be a static value that does not change. The SuccessEHS Patient ID (MRN) must be returned in the PID segment as received in the ORM message as well as the SuccessEHS Requisition ID (Placer Order ID) in the ORB segment. Health center clinics must have the ability to print the official copy of the report with the vendor's logo and information.

REQUIREMENTS

Section – I: Acceptable Candidates must meet all of the following criteria:

- e) Bidder must provide a twenty-four-hour turnaround time for routine laboratory tests and provide a two-hour turnaround time for STAT tests (See Appendix C). STAT tests shall be allowed at no charge. Pap Smear reports submitted electronically back to the health centers within one week of pickup.
- f) Bidder must provide supplies necessary for collection, packaging, and transportation and pick up of specimens.
- g) Bidder must provide laboratory request form with the printed name of each health center or off-site clinic laboratory site, and divided for each service area (FP, AH, CH, DC).
- h) Bidder provide third party billing.
- i) Bidder will accurately invoice each health center clinic laboratory site for laboratory tests and when errors are noted make corrections within 30 days of notification.
- j) Bidder to provide quarterly reports by each health center on the following:
 - Total number of all tests obtained with breakdown of result categories and percentages.
 - Pap Smears classified with other than normal with patient name, chart number and provider number obtaining specimen.
 - Information as to verification of abnormal slide by pathologist.
 - Categorized Specimen rejections list
- k) Bidder to provide statements for services in an auditable format and rendered on a monthly basis. Statements to include patient demographics, chart number and program area.
- l) Telecommunication to be provided as part of service.
- m) Cost per test. (See Appendix A and B)
